



Users' Terms and Conditions

REGISTRATION

All Users using MasterEload system must be 18 years old or above. Users are to pay a system set up fees and a minimum start up capital to use the MasterEload system.

All users must have an introducer, once signed up, no change of introducer is allowed.

All reload pin sold are in Reload Point (RP). Users have to buy Reload Point (RP) to top up to their account in order to sms/online order reload pins or products.

1Reload Point = RM1.00

YEARLY SYSTEM MAINTENANCE FEES

A yearly system maintenance fees is deductible on the 1st day of August of every year. Users who failed to pay the yearly system maintenance fees will not be entitled for yearly system maintenance fees rebate for that particular year.

TOP UPS

Users may top up their credits by banking into any of Summit Priority Sdn. Bhd. bank accounts, and fax or sms to inform the MasterEload head office.

Users may also top up their account through MasterEload Mobile Center. Summit Priority Sdn. Bhd. is not responsible for any amount of money passed to Mobile Center which was misused by the Mobile Center.

The minimum top up amount for user is 50RP. 0.20RP sms cost is deductible for amount top up less than 100RP. Outstation bank charges are to be charged to the user's account.

Top up sms command: ME<>Password<space>bank<space>bank name, date, time,amount & any reference no.

All cash banked in will take 30minutes to 1 hour to top up to users' account during office hour and 3 to 5 working days for cheques top up upon clearance of the cheque.

INCENTIVES

Only Active User is entitled for his total sales rebates.

Active User means User who has order minimum 10RP reload or pin in one calendar month.

Users' Total Sales rebates are calculated base on each calendar month.

Entrepreneur ship Rebates are top up immediately to the User's account. Total sales rebate and Master Fund will be top up to the Users account on the 7th of the next month.

INVALID PIN NUMBERS

Orders made by error or sent by mistake are not refundable, returnable or exchangeable for other products.

Summit Priority Sdn. Bhd. is not responsible for any pin number being used after the order time.

No pin number will be given over the phone, user has to come personally or the pin no. will be resend to his handphone number. 0.15RP sms cost will be deducted from the user's account for any e-pin number resend.

ERROR SMS

All SMS send with wrong command to MasterEload server will be charged 0.15RP to the User's account for any reply SMS cost.

PASSWORD AND WEB PASSWORD

Summit Priority Sdn. Bhd. is not responsible to any User's password/ web password exposed to others or misused of his password or web password. User may change his password or web password via sms or online anytime, anywhere.

0.20RP sms cost is chargeable to the user's account for change of password and web password

CHECK BALANCE

0.20RP sms cost is charged to the User's account for check balance command.

INCENTIVE STATEMENT

Users may view or print out their rebate statement by login to their web page. Any request of printing rebate statement will be charged 1.00RP per copy. 2.00RP per copy will be charged for fax over the statement and 2.00RP per copy for sending by postage.

UPDATE DATA

3RP will be charged to Users' accounts for any changes or updates requested; e.g. change of hand phone number, all requests must be written and signed by the User and one witness (his/her introducer) Agent may update his address or bank information by login to his User page.

RESIGNATION

All resignation must be written. A refund cheque will be issued in the name of the User and an administration free of 3.00RP is deducted. The User may registered as an User again after 3 months of resignation and at the discretion of the management.

RELOAD POINT REDEMPTION FOR CASH

User may redeem their Reload Point for cash anytime anywhere. Minimum redemption is 4RP. An administration fees of 3.00RP is charged. All cheques are issued on every Friday of the week.
